- If you need more space, please continue on a separate sheet.
- Please make sure you clearly show whether items such as interest, dividends or pension payments are gross or net of tax. If you have a business bank account as a sole trader or partnership, any interest earned on your current account needs to be noted for inclusion on your personal tax return.
- If you are a director of a company and we act for the company on payroll matters then you do not need to enter amounts for salary, benefits, expenses or dividends. You should mention that the source of income is received though.
- If you are self employed then this form is separate to your business accounts. Items such as rent, pension payments, interest or similar should still be shown, even if reported in the business accounts.
- If your business year end is 31 March or 5 April and your business is very small, please enclose the business records along with your tax records.
- Where income is shared with another person, eg joint savings accounts, please indicate clearly whether the figures given are your share or the total.
- If there is anything that you think is relevant to your tax affairs but not covered in this form then please provide details.
